APPROVING RESOLUTION NO. 8-S-2021 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 FOR CY-2021 OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN AMOUNTING TO ONE MILLION PESOS"

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 8-S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of San Fabian, Pangasinan prepared the Supplemental Annual Investment Program (AIP) No. 1 for CY 2021. This was endorsed by the Council, through MDC Resolution No. 01, S-2021 dated January 25, 2021 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 8, S-2021 dated January 27, 2021;

WHEREAS, said Supplemental AIP, which has an investment requirement of P1,000,000.00, intended for the Purchase of Lot for Right-of-Way, with an area of 700 square meters, located at Barangay Bolasi, San Fabian;
