RESOLUTION NO. 366-2021

APPROVING RESOLUTION NO. 341, S-2019-22 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 5 OF THE CITY OF URDANETA FOR CY 2020 IN THE AMOUNT OF THIRTY-SEVEN MILLION NINE HUNDRED SEVENTY-NINE THOUSAND TWO HUNDRED FORTY-FOUR PESOS ONLY (P37,979,244.00)"

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Resolution No. 341, S-2019-22 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Urdaneta City, Pangasinan has formulated and endorsed the city's Supplemental Investment Program No. 5 thru CDC Resolution No. 6, S-2020 dated November 12, 2020 to the Sangguniang Panlungsod for approval. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 5 with an investment requirement amounting to P37,979,244.00 covers fund augmentation for the maintenance and other operating expenses, capital outlay of offices in the city government and DRRM activities. However, the municipality should specify the items to be funded out of the LDRRMF in accordance with RA No. 10121 and NDRRMC-DBM-DILG JMC No. 2013-1;


