APPROVING RESOLUTION NO. 128, S-2021 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) OF THE MUNICIPALITY OF CALASIAO FOR THE YEAR 2021"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 128, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. The Municipal Development Council Executive Committee of Calasiao, Pangasinan has prepared the municipality's Supplemental Annual Investment Program for CY 2021. This was endorsed by the Council, through MDC Resolution No. 07, Series of 2021, dated December 17, 2021 to the Sangguniang Bayan for approval;
- 2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱2,367,000.00, covers the granting of Service Recognition Incentives (SRI) to qualified personnel, and implementation of GAD and LDRRM projects/activities of the LGU; and

3. Funding for the Supplemental AIP is embodied in their Supplemental Budget No. 4, FY 2021, and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 13, Series of 2021 dated December 29, 2021.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;
