PROVINCIAL RESOLUTION NO. 373-2020

EXTENDING THE DEADLINE FOR THE PAYMENT OF TAXES, FEES AND CHARGES IMPOSED AND COLLECTED BY THE PROVINCE, AND FOR THE AVAILMENT OF THE 20% DISCOUNT ON ADVANCED PAYMENT UP TO JUNE 25, 2020 ON CURRENT REAL PROPERTY TAXES WITHIN THE TERRITORIAL JURISDICTION OF PANGASINAN

WHEREAS, Provincial Resolution No. 322-2020 of the Sangguniang Panlalawigan dated March 18, 2020 extended the payment of current real property taxes within the territorial jurisdiction of the Province of Pangasinan for the availment of the twenty percent (20%) discount from March 31, 2020 to May 31, 2020;

WHEREAS, Section 4 of Department Circular No. 002-2020 of the Department of Finance which mandates the extension of deadlines for the payment of all local taxes, fees and charges duly authorized and imposed by local government units within their respective territorial jurisdiction as of March 25, 2020 shall be extended until June 25, 2020;

WHEREAS, finding that the said DOF Department Circular can ease the burden on individuals under community quarantine, the Provincial Treasurer has suggested the extension of real property tax discounts relative to 20% discount on Advanced Payment up to June 25, 2020;

WHEREAS, the Sangguniang Panlalawigan deemed it proper to extend also the deadline on the availment of the discount for the payment of current real property taxes;

WHEREFORE, in view of the foregoing, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –
