RESOLUTION NO. 376-2020

DECLARING ORDINANCE NO. 2019-07 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING THE ALAMINOS CITY TECHNICAL-VOCATIONAL INSTITUTE AND ASSESSMENT CENTER (ACTVIAC) AND PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2019-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 129, 132 and 458 (a) (5) (x) of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sanggunian has complied with the requirements set forth in Sections 187 and 188 of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2019-07 of the Sangguniang Panlungsod of **Alaminos**, Pangasinan, entitled "An Ordinance establishing the Alaminos City Technical-Vocational Institute and Assessment Center (ACTVIAC) and providing funds therefor and for other purposes" as within the conferred powers of the Sangguniang Panlungsod to enact;


