RESOLUTION NO. 377-2022

APPROVING RESOLUTION NO. 75, S-2021 OF THE SANGGUNIAN BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PLAN OF THE MUNICIPALITY OF AGUILAR CY 2022"

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 75, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Aguilar, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2022. This was endorsed by the Local Development Council to the Sangguniang Bayan on June 21, 2021 thru MDC Resolution No. 4, Series of 2021 and was favorably acted upon by the Sangguniang Bayan on November 29, 2021 thru SB Resolution No. 75-S-2021;

2. The Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units – 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 Series of 2007 dated 08 March 2007 and DBM-CCC-DILG JMC No. 2014-dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-1 – dated July 23, 2015 as to format and contents. The AIP of Aguilar, Pangasinan was formulated following the prescribed AIP Summary Form and covers a) all the regular budgetary requirements for the operation of the different municipal offices broken down into PS, MOOE and Capital Outlay; b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund; c) disaster risk reduction programs, projects and activities; d) Peace and Order Plan; e) Gender and Development Plan; f) Nutrition Plan; g) Local Climate Change Action Plan, h) Municipal Tourism and Cultural Plan; and i) list of programs, projects and activities (PPAs) for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities. It is advised however, that the LGU concerned shall also include other attachments to the AIP as per Section 2.2.17 of Local Budget Memorandum No. 82, dated June 14, 2021, namely: Local Youth Development Plan, Annual Cultural Development Plan, Annual Procurement Plan and List of PPAs to address problems on Illegal Drugs and PPAs to combat AIDS;
3. The proposed AIP of Aguilar for CY 2022 has an investment requirement of P232,272,015.00 Funding support for the implementation of which is embodied in their 2022 proposed Annual Budget, which was passed and approved by their Sangguniang Bayan on December 27, 2021 thru Appropriation Ordinance No. 6, Series of 2021;
4. This AIP is in accordance with Section 287 of LGC of 1991. Twenty percent (20%) of the LGU's National Tax Allotment (P222,098,015.00), which is equivalent to P44,419,603.00 is allocated for development projects. These development projects are based on Joint DBM-DOF-DILG Memorandum Circular No. 1, dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects;

5. The Disaster Risk Reduction and Management Programs/Projects/Activities in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P11,490,600.75) were based on Section 21 of RA 10121. The programs, projects and activities to be funded by 70% of the 5% LDRRMF in the amount of P8,043,420.53 were based on NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of Interior and Local Government. (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). It is respectfully suggested that the DRRM Plan shall be submitted by the LGU to the Office of Civil Defense (OCD) for review as per Local Budget Memorandum No. 77, dated May 15, 2018 and Local Budget Memorandum No. 82, dated June 14, 2021;
6. The LGU of Aguilar had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
7. The Gender and Development Programs, Projects and Activities (GAD-PPAs) attached were reviewed by the DILG Provincial Office and were found to be fully compliant in form and in contents with the provisions of the Joint Memo-Circular (DBM, PCW, DILG & NEDA) No. 2016-01: Amendments to JMC 2013-01 or the Guidelines on the Localization of the Magna Carta of Women;
8. As to the Devolution Transition Plan (2022-2024), as one of the supporting documents of this AIP, it is respectfully recommended that the LGU shall strictly observe Item 3.2 of DBM Local Budget Memorandum No. 82-A dated August 19, 2021 which states that "Considering the timeline on the preparation and submission of the LGU DTP under DBM-DILG JMC No. 2021-1, the LCE shall not be mandatorily required to include the LGU DTP as part of the supporting documents of the AIP and the LEP to be submitted to the local sanggunian for budget authorization purposes. However, in case the LGU has already prepared and approved its LGU-DTP, the same may be part of the supporting documents of the AIP and LEP to be submitted by the LCE to the local sanggunian". Further, item 6.3.2 of the DBM-DILG Joint Memorandum Circular No. 2021-1 dated August 11, 2021 advised LGUs to "integrate fully assumed responsibilities in the updating of their local development plans, sectoral thematic plans and investment programs".
