RESOLUTION NO. 381-2021

DECLARING MUNICIPAL ORDINANCE NO. 2021-03 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "AN **ORDINANCE** REQUIRING THE **MANDATORY** INSTALLATION OF ROAD WARNING AND SAFETY DEVICES (RWSDS) BY ALL CONTRACTORS AND PUBLIC UTILITY COMPANIES ON ALL ON-GOING ROAD AND BRIDGE CONSTRUCTIONS/MAINTENANCE ALONG THE NATIONAL, PROVINCIAL, MUNICIPAL AND BARANGAY ROADS WITHIN THE JURISDICTION OF THE MUNICIPALITY OF ALCALA, PANGASINAN AND PROVIDING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Ordinance No. 2021-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) and (5) (v) of RA 7160; DPWH Department Order No. 135, Series of 2015;

WHEREAS, the Sangguniang Bayan is hereby reminded on the principle that the prosecution for violation of local ordinances and the imposition of corresponding penalties can be done only after it has proven in court of competent jurisdiction as provided for under Section 447 (1) (iii) of the Local Government Code of 1991;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2021-03 of the Sangguniang Bayan of **Alcala**, Pangasinan, entitled "An Ordinance requiring the mandatory installation of Road Warning and Safety Devices (RWSDS) by all contractors and public utility companies on all on-going road and bridge constructions/maintenance along the national, provincial, municipal and barangay roads within the jurisdiction of the Municipality of Alcala, Pangasinan and providing penalties thereof" as within the conferred powers of the Sangguniang Bayan to enact;
