RESOLUTION NO. 381-2022

APPROVING MUNICIPAL RESOLUTION NO. 98-2021 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 01 OF THE MUNICIPALITY OF NATIVIDAD, PROVINCE OF PANGASINAN FOR CY-2021 WITH AMENDMENTS"

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its Municipal Resolution No. 98-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council Executive Committee of Natividad, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No.1 thru MDC Execom Resolution No. 02-2021 dated December 14, 2021 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan through Resolution No. 98-2021 dated December 24, 2021 with some amendments;
2. Likewise, on December 24, 2021, the Sangguniang Bayan enacted Supplemental Budget No. 1 through Appropriation Ordinance No. 02-2021 with amendments to support the implementation of the programs embodied in the Supplemental Investment Program No. 1;

3. The Mayor approved Appropriation Ordinance No. 02-2021 on December 27, 2021, but vetoed the amended items;
4. The Sangguniang Bayan of Natividad passed Municipal Resolution No. 01-2022 dated January 10, 2022 overriding the veto message of the Mayor, but due to lack of vote to override the veto which needs 2/3 vote of all members, the motion to override failed.

WHEREAS, the increase in appropriation for Financial Assistance to LGU-Contractual employees is hereby not approved, as per review and recommendation of the Provincial Local Finance Committee;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Natividad, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—


