APPROVING RESOLUTION NO. 98, S-2021 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 2 WITH THE CY 2021 SUPPLEMENTAL ANNUAL INVESTMENT PLAN NUMBER 1 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 98, Series of 2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Asingan, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2021, which was endorsed to the Sangguniang Bayan for approval on March 5, 2021 through MDC Resolution No. 2, S-2021;

**WHEREAS**, the Supplemental Investment Program No. 1 of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay of some municipal offices and implementation of various programs/projects/activities including Covid-19 pandemic-related projects;

**WHEREAS**, the Supplemental Investment Program No. 1 has an investment requirement of P13,190,851.55. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 1 CY 2021, which was passed and approved by their Sangguniang Bayan on March 8, 2021 through Appropriation Ordinance No. 1, S-2021;
