RESOLUTION NO. 383-2021

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2021 OF ASINGAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P13,190,851.55 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2021 involving total appropriations of **P13,190,851.55** which was approved on March 8, 2021 through Appropriation Ordinance No. 1, S-2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. The disbursement of Monetization of Leave Credits shall be subject to the provision of Budget Circular No. 2016-2 dated March 29, 2016 re: *Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits which provides for the new constant factor stated under Item 3.1 thereof;*

3. The appropriation for the grant of Performance-Based Bonus (PBB) shall not be disbursed until such time a circular granting the same is issued by proper authority, otherwise, the same shall be declared bereft of legal basis;
4. The grant of Anniversary Bonus shall be in accordance with the provision of Local Budget Circular No. 65 dated March 3, 1997, particularly Items 4.3 and 4.5 thereof;
5. The appropriation and disbursement of Public Affairs Fund shall be spent solely for public purposes and no amount shall be applied for religious or private purposes pursuant to Sections 305 (b) and 335 of RA 7160, and shall be broken down into appropriate objects of expenditures, as may be applicable, in accordance with the Revised Chart of Accounts for LGUs under COA Circular 2015-009 dated December 1, 2015;
6. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2021 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007 and DILG-DBM Joint Memorandum Circular No. 01, S-2007 dated 27 March 2020; *and*
7. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 1 for Calendar Year 2021 of Asingan, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Asingan;
