PROVINCIAL RESOLUTION NO. 392-2019

DETERMINING THE MEMBERSHIP OF THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD AS PROVIDED FOR UNDER RA 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Section 80 of RA 7160, otherwise known as the Local Government Code of 1991, provides that a Personnel Selection Board must be established in every province to assist the local chief executive in the judicious and objective selection of personnel for employment as well as for promotion and in the formulation of such policies as would contribute to employee welfare;

WHEREAS, the Sangguniang Panlalawigan is authorized to determine by a resolution the members of the Provincial Selection Board;

WHEREAS, Section 88 of the 2017 Omnibus Rules on Appointments and other Human Resource Actions, Revised July 2018 provides for the composition of the Human Resource Merit Promotion and Selection Board (HRMPSB);

WHEREAS, Section 90 thereof further provides that the membership of the HRMPSB can be modified provided it conforms to the prescribed composition. Agencies may add a reasonable number of members but the prescribed composition may not be reduced;

WHEREAS, the Human Resource Merit Promotion and Selection Board of the Province of Pangasinan shall be composed of the following:

Chairman - The Local Chief Executive, or his/her authorized representative;

Vice Governor or his/her authorized representative, if the vacant position is in his/her Office or in the Office of the Sanggunian;

Members - Chairman and the Vice Chairman of the Committee on Human Resources and Development, Labor and Employment Concerns of the Sangguniang Panlalawigan;

Head of organizational unit where vacancy exists, or his/her designated alternate;

Human Resource Management Officer (HRMO) or the career service employee directly responsible for recruitment, selection and placement, or his/her designated alternate; *and*


Two (2) regular and alternate representatives of the rank and file career employees, from the first level and from the second level, who shall all be chosen by the duly accredited employees association in the agency.

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to determine, as it is hereby determined, the membership of the Human Resource Merit Promotion and Selection Board as provided for under RA 7160, otherwise known as the Local Government Code of 1991;

RESOLVED, FINALLY, that copies of this resolution be furnished to Governor Amado I. Espino III, Vice Governor Mark Ronald DG. Lambino and the members of the Human Resource Merit Promotion and Selection Board, for their information and guidance.
