PROVINCIAL RESOLUTION NO. 399-2019

CREATING AN AD HOC COMMITTEE TO REVIEW AND FURTHER ASCERTAIN THE STATUS OF OPERATION OF THE LINGAYEN AIRPORT

WHEREAS, Section 67 of the Internal Rules of Procedure of the 10th Sangguniang Panlalawigan of Pangasinan provides that a Special or Ad Hoc Committee shall, from time to time, be created by the Sanggunian for special or specific purposes which shall cease to exist as soon as the Sanggunian shall have received its report;

WHEREAS, transportation factor should also be addressed by the Provincial Government in promoting development thrust to make Pangasinan a premier province;

WHEREAS, the Sangguniang Panlalawigan expressed its concern over the status of operation of the Lingayen Airport considering that it is one of the major infrastructure projects in the Province;

WHEREAS, the Lingayen Airport should also be looked upon by the Sangguniang Panlalawigan, in aid of legislation, for the enactment of legislative measures that could further enhance the upgrading and improvement of the same;


