## PROVINCIAL RESOLUTION NO. 401-2019

URGING THE CRAFTING OF A MASTER DEVELOPMENT PLAN FOR THE LAND USE OF THE PROVINCIAL CAPITOL COMPLEX

WHEREAS, various offices of the Provincial Government including that of national government agencies are presently located in the Provincial Capitol Compound;

WHEREAS, several national government agencies are already established in the Provincial Capitol Compound either through a deed of donation, usufruct, or lease;

WHEREAS, considering the present situation of the Provincial Capitol Compound which is beginning to be congested with such government offices, there is a need therefore to craft a master development plan for the land use of the area;

WHEREAS, the Sangguniang Panlalawigan desires to have a clearer picture of the physical status of the Provincial Capitol Complex and come up with a comprehensive and feasible use of the vicinity;

WHEREAS, it is about time that the buildings, social settings and environmental surroundings of the Provincial Capitol Compound be made with a master development plan in order to have a more systematic, aesthetic and orderly disposition of the area that could best guide not only the present administration but for future generations;

WHEREAS, it is essential that a master development plan be crafted the soonest possible time to be led by the Provincial Land Use Committee;
