**RESOLUTION NO. 403-2020**

**APPROVING RESOLUTION NO. 19(A)-087 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2020 OF THE CITY GOVERNMENT OF SAN CARLOS, PANGASINAN"**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 19(A)0-087 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The City Development Council of San Carlos, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2020. This was endorsed by the Council to the Sangguniang Panlungsod thru CDC Resolution No. 09-19 (Series of 2019) dated October 14, 2019 and was favorably acted upon by the Sangguniang Panlungsod through SP Resolution No. 19(A)-087 dated December 16, 2019;

**WHEREAS**, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of San Carlos City, Pangasinan has prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction (DRR) Programs/Projects/Activities, and d) activities in pursuance of the objectives of GAD of the LGU. Also attached to the AIP, among others, are the following: a) Local Climate Change Action Plan, b) Localized Anti-Criminality Action Plan, c) list of programs/projects/activities (PPAs) for the Local Council for the Protection of Children, and d) list of programs/projects/activities (PPAs) for Senior Citizens and Persons with Disabilities;

**WHEREAS**, the AIP of San Carlos City for CY 2020 has a total investment requirement of P1,105,962,511.23. Of this, the sum of P905,962,511.23 will be financed by the LGU as embodied in their 2020 Annual Budget passed and approved by the Sangguniang Panlungsod through Appropriation Ordinance No. 19-20 dated December 16, 2019. The remaining amount of P200,000,000.00 will be sourced from the national government agencies;

**WHEREAS**, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P762,356,382.00), amounting to P152,471,276.40 is allocated for development projects;

**WHEREAS**, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

**WHEREAS**, the programs and projects included in the 5% Local Disaster Risk Reduction and Management Investment Plan/Program, amounting to P43,745,101.75, were already reviewed by the Office of the Civil Defense – Regional Office I as part of their Six-Year LDRRM Plan (2019-2024) and the LGU was advised to consider to adopt the necessary amendments to the Plan and submit the revised Plan to the OCD-ROI;

**WHEREAS**, the LGU of San Carlos City had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

**WHEREAS**, the Gender and Development Plan and Budget for CY 2020 of the LGU has been reviewed and approved by the Department of Interior and Local Government (DILG) Provincial Office, and found to be compliant in form and in contents with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


