RESOLUTION NO. 405-2020

APPROVING SB RESOLUTION NO. 19-2020 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “APPROVING THE 1ST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF MANAOAG, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its SB Resolution No. 19-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Manaoag, Pangasinan prepared the Supplemental Annual Investment Program (AIP) for CY 2020. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 01, Series of 2020 dated April 11, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 19-2020 dated April 14, 2020;

WHEREAS, said Supplemental AIP, which has a total investment requirement of P42,986,510.00, intended to finance Programs, Projects and Activities (PPAs) as part of the COVID-19 response, relief and rehabilitation, such as the provision of food assistance and other relief goods for affected families; procurement of Personal Protective Equipment (PPEs) and reagents, disinfectants, sprayers, disinfection tents and other disinfecting supplies and misting equipments; provision of food, transportation/fuel and accommodation expenses to involved medical personnel, and other necessary COVID-19 related PPAs and expenses of the LGU;
