RESOLUTION NO. 409-2022

DECLARING MUNICIPAL ORDINANCE NO. 12-2021 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE TWENTY-THREE THOUSAND EIGHT HUNDRED TWENTY-TWO (23,822) SQUARE METERS, MORE OR LESS OF PARCELS OF LAND COVERED BY TCT NO. 027-2021000989- (12,867 SQ.M.), TCT NO. 027-2021000987 - (10,455 SQ.M.) AND TCT NO. 3071 - (500 SQ.M.) LOCATED AT BARANGAY MAL-ONG, ANDA, PANGASINAN AND REGISTERED UNDER PANGASINAN ELECTRIC COOPERATIVE I (PANELCO-I), FROM AGRICULTURAL LAND TO COMMERCIAL/INDUSTRIAL LAND" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 12-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator, Provincial Agrarian Reform Program Officer II, and Department of Human Settlements and Urban Development Regional Director have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160 and Rule VII Article 38 of the Implementing Rules and Regulations of R.A. 7160;
