**DECLARING MUNICIPAL ORDINANCE NO. 01-2022 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING ORDINANCE NO. 13-2021 CAPTIONED “CREATING THE PLANTILLA POSITION OF MUNICIPAL RISK REDUCTION AND MANAGEMENT OFFICER V (LDRRMO V) OF LGU MANAOAG, PANGASINAN” TO “CREATING THE POSITION OF MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (LOCAL RISK REDUCTION AND MANAGEMENT OFFICER)” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**
