APPROVING AND ADOPTING AS ITS DECISION EN BANC, THE RESOLUTION/RECOMMENDATION OF THE COMMITTEE ON GOOD GOVERNMENT AND ACCOUNTABILITY OF PUBLIC OFFICERS, JUSTICE AND HUMAN RIGHTS IN SP ADMINISTRATIVE CASE NO. 02-2019

WHEREAS, the Sangguniang Panlalawigan is in receipt of a verified administrative complaint filed on September 23, 2019 by Conrado R. Ignacio against Mayor Julius Ramos of Sta. Maria, Pangasinan for Oppression and Misconduct and which was referred to the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights as SP Administrative Case No. 02-2019;

**WHEREAS**, the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights, on January 20, 2020 submitted its Resolution embodied in Committee Report No. 02-2020, to wit:

#### RESOLUTION

Received by the Sangguniang Panlalawigan on September 23, 2019 is an administrative complaint filed by Mr. Conrado R. Ignacio against Mayor Julius Ramos of Sta. Maria, Pangasinan for Oppression and Misconduct. The case was docketed by the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights as SP Administrative Case 2-2019;

The Pre Trial Conference was held on November 22, 2019;

On December 6, 2019, a Compromise Agreement signed by both parties was submitted which settled the case amicably.

THEREFORE, the Committee adopts the Compromise Agreement and hereby DISMISSES the above-captioned case.
