DECLARING ORDINANCE NO. 10 S-2021 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "AN ORDINANCE IMPOSING THE COST OF PER CHAMBER (NICHE, COLUMBARIUM) OF THE NEWLY CONSTRUCTED APARTMENT-TYPE CEMETERY BUILDING OF THE MUNICIPALITY OF ASINGAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Municipal Ordinance No. 10, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (a) and (b) (2) (x), 447 (a) (3) (i) and (4) (ix) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, subject ordinance shall take effect after the requirements of public hearing, publication and posting are complied with pursuant to 187, 188 and Section 59 (a) of RA 7160 are complied with;


