## **RESOLUTION NO. 424-2019**

**DECLARING ORDINANCE NO. 19-06 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE REVISING ORDINANCE NO. 66-06, ENTITLED "AN ORDINANCE PROMULGATING THE GENDER AND DEVELOPMENT CODE OF THE CITY OF SAN CARLOS IN PANGASINAN AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 19-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the power of the Sangguniang Panlungsod to enact and approve ordinances or resolutions carries with it the power to amend, revoke, modify or repeal the same;

**WHEREAS**, the enactment of the amended ordinance is in pursuance to the Gender and Development Code of the Philippines; RA 7192 (An Act Promoting the Integration of Woman as Full and Equal Partners of Men in Development and Nation Building and For Other Purposes); RA 9710 (Magna Carta of Women); and Section 17 of RA 7160;
