APPROVING RESOLUTION NO. 18-095 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 10 FOR CALENDAR YEAR 2018 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 18-095 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council-Executive Committee of San Carlos City, Pangasinan has prepared the city's Supplemental Investment Program No. 10 for CY 2018. This was endorsed thru CDC Resolution No. 15-18 dated September 21, 2018 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 18-095 dated September 24, 2018;

WHEREAS, the Supplemental Investment Program, which has a total investment requirement of P321,834,000.00 covers infrastructure projects and purchase of equipment for the Waste Management Program of the city;
