## **RESOLUTION NO. 426-2022**

## DECLARING MUNICIPAL ORDINANCE NO. 2020-01 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING SUSTAINABLE MILK FISH CULTURE WITHIN THE MUNICIPAL WATERS OF BOLINAO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Ordinance No. 2020-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (b) (2) (i), 149 (a) (b) (1), 447 (a) (5) (1) (vi) of R. A. No. 7160 and Republic Act No. 8550 entitled "An Act Providing for the Development, Management and Conservation of the Fisheries and Aquatic Resources, Integrating all Laws Pertinent Thereto, and for Other Purposes";

WHEREAS, however, the Sanggunian Bayan is reminded on the principle that imposition of penalties for violation of ordinances is similar to that of prosecution of criminal cases and special laws, where a court order is necessary to impose the penalty. This is provided in Section 447 (1) (iii) of R.A. No. 7160. Although the local legislative body has the regulatory power to issue and revoke permits, it cannot be effected without due process of law;
