PROVINCIAL RESOLUTION NO. 427-2020

APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2020

WHEREAS, presented for consideration is the Supplemental Investment Program No. 3 of the Province of Pangasinan as endorsed by the Provincial Development Council through PDC EXECOM Resolution No. 06-20;

WHEREAS, Supplemental Investment Program No. 3 contains other priority programs, projects and activities that are not included in the approved 2020 Provincial Annual Investment Program of Pangasinan;

WHEREAS, the Supplemental Investment Program No. 3 shall cover the reprogramming of the following programs, projects and activities to be funded from the Bayanihan Grant to Provinces: From Construction of Crematorium; Purchase of Various Hospital Equipment-IV Stand; Purchase of N95 Masks to Purchase of Additional Equipment for Molecular Laboratory at the Pangasinan Provincial Hospital and Development Fund from portion of Community Development Projects to Various COVID-19 Related Activities of the Province;

WHEREAS, the **P47,385,000.00** total investment requirement of Supplemental Investment Program No. 3 is fully supported by Supplemental Budget No. 3 which shall be sourced from the reversion of portion of Bayanihan Grant to Provinces amounting to **P13,600,000.00** and Development Fund – Community Development Projects amounting to **P33,785,000.00**;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


