**RESOLUTION NO. 43-2022**

**DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2022 OF MANGALDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P455,461,766.00, OPERATIVE IN PART**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Annual Budget for Calendar Year 2022 involving total appropriations of P455,461,766.00, which was enacted on November 5, 2021 through Appropriation Ordinance No. 2021-22;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the implementation of the Third Tranche Compensation Adjustment for all municipal officials and employees shall be subject to the provisions of Executive Order No. 76 of the Office of the President dated March 15, 2019 and specific guidelines to be issued by the Department of Budget and Management;
2. That the grant of step increment to some municipal employees and elective officials shall be in accordance with the CSC-DBM Joint Memorandum No. 1, S-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016;

3. That the appropriation for Other Personnel Benefits shall only be disbursed upon issuance of guidelines granting the same, otherwise, the same shall be deemed bereft of legal basis;
4. That the appropriation and disbursement of Election Reserve in the amount of Php1,000,000.00 shall be in accordance with COMELEC Resolution No. 10695 promulgated on February 10, 2021;
5. That the projects under the 20% of the Annual National Tax Allotment (NTA) for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020. Re: Revised Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual National Tax Allotment for Development Projects;
6. That the appropriation for devolved functions and services in FY 2022 shall be in accordance with the provisions of Executive Order No. 138 dated June 1, 2021 and DBM-DILG Joint Memorandum Circular No. 2021-1 dated August 11, 2021 and shall be consistent with Devolution Transition Plan of the municipality;
7. That the Plantilla of Personnel shall be made an integral part of the ordinance thereof;
8. That the items funded out of the Local Disaster Risk Reduction and Management fund shall be in accordance with R. A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF), and that 30% shall be set aside as Quick Response Fund. Provided further that the appropriation shall be subject to Section 324 (d) of R.A. No. 7160 and Section 21 of R.A. 10121;
9. That all procurements to be undertaken shall be subject to the provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations; and
10. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007.

**WHEREAS**, however, the appropriation for Representation and Transportation Allowance of LDRRMO IV SG 22/1 under the Office of the Municipal Mayor is not approved. Said position is not equivalent to Municipal Government Assistant Department Head (MGADH) and is not included among the positions entitled to RATA under Local Budget Circular NO. 103 dated May 15, 2013;

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative In Part the Annual Budget for Calendar Year 2022 of Mangaldan, Pangasinan;

**RESOLVED FURTHER**, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Mangaldan, Pangasinan, for its information and guidance.
