PROVINCIAL RESOLUTION NO. 433-2021

AUTHORIZING THE PROVINCIAL GOVERNOR AND THE PROVINCIAL TREASURER TO OPEN NEW ACCOUNT/S WITH THE LAND BANK OF THE PHILIPPINES-UMINGAN BRANCH TO TRANSFER THE FUNDS DEPOSITED AT THE LAND BANK OF THE PHILIPPINES-TAYUG BRANCH

WHEREAS, the Land Bank of the Philippines is an authorized depository bank of the Provincial Government of Pangasinan;

WHEREAS, the Umingan Community Hospital maintains depository accounts with the Land Bank of the Philippines-Tayug Branch;

WHEREAS, the funds of the Umingan Community Hospital with the Land Bank of the Philippines-Tayug Branch will be transferred to the Land Bank of the Philippines-Umingan Branch for convenience, security and safety purposes;

WHEREAS, for this purpose, there is a need to close the existing account of Umingan Community Hospital with Land Bank of the Philippines-Tayug Branch;

WHEREAS, the Sangguniang Panlalawigan is therefore authorizing the Provincial Governor and the Provincial Treasurer to open new account/s of Umingan Community Hospital with the Land Bank of the Philippines-Umingan Branch;

NOW THEREFORE, on motion of SP Members Angel M. Baniqued, Jr. and Jeremy Agerico B. Rosario, duly seconded, it was -


