DECLARING ORDINANCE NO. 11-S-2021 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "AN ORDINANCE ADOPTING THE HOUSING AND LAND REGULATORY BOARD (HLURB) NOW DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DHSUD) REVISED SCHEDULE OF FEES IN THE MUNICIPALITY OF SAN FABIAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 11, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (2) (ix) (3) (i) of R. A. No. 7160 and Executive Order No. 71, otherwise known as the "Devolving the Powers of the Housing and Land Use Regulatory Board to Approve Subdivision Plans, to Cities and Municipalities pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of public hearing, publication and posting pursuant to Sections 187, 188, 511 (a) and 59 (c) of R.A. 7160;
