APPROVING RESOLUTION NO. 23-2021 OF THE SANGGUNIANG BAYAN OF URBIZONDO, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF URBIZONDO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Urbizondo, Pangasinan submitted its Resolution No. 23-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991;

WHEREAS, the Local Development Council of Urbizondo, Pangasinan endorsed to the Sangguniang Bayan for approval the Revised Annual Investment Program CY 2021 to the Sangguniang Bayan for approval on April 6, 2021 by the Municipal Development Council through MDC Resolution No. 1, Series of 2021;

WHEREAS, the 2021 AIP of the Municipality of Urbizondo, Pangasinan was revised to integrate the Revised Local Risk Reduction and Management Fund Investment Plan (LDRRMIP) prepared and endorsed by the LDRRM Council through MDRRMC Resolution No. 01, Series of 2021. The LDRRMIP includes programs, projects and activities in response to the crisis due to COVID-19 pandemic, which were proposed to be funded by the municipality's unexpended balances of their LDRRMF CYs 2017, 2018,

2019 and 2020 Trust Fund in the amount of P3,490,510.56. This is in accordance with Item 6.5 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;

WHEREAS, the Revised AIP also includes priority projects proposed to be funded by the National Government through the Financial Assistance to LGUs National Disaster Risk Reduction and Management Fund FY 2020 (P3,848,245) and Local Government Fund – Disaster Rehabilitation and Reconstruction Assistance Program (P4,164,347.00);


WHEREAS, the Sangguniang Panlawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Urbiztondo, Pangasinan;


