PROVINCIAL RESOLUTION NO. 446-2019

INVITING POLICE COLONEL REDRICO A. MARANAN, PROVINCIAL DIRECTOR, TO APPEAR BEFORE THE SANGGUNIANG PANLALAWIGAN DURING ITS QUESTION HOUR ON SEPTEMBER 2, 2019 REGULAR SESSION TO APPRISE AND UPDATE THE AUGUST BODY ON THE PEACE AND ORDER SITUATION OF THE PROVINCE AND THE NEW PLANS AND PROGRAMS OF THE PRESENT ADMINISTRATION OF THE PANGASINAN POLICE PROVINCIAL OFFICE ESPECIALLY ON THE VERIFICATION OF ALLEGED POSSIBLE TERROR ATTACKS IN AREAS WITHIN THE NORTHERN LUZON TO INCLUDE MANAOAG, PANGASINAN

WHEREAS, the Philippine National Police is mandated to enforce law to prevent and control crimes, maintain peace and order and ensure public safety and security with the active support of the community;

WHEREAS, the Pangasinan Police Provincial Office has a new Provincial Director with the assumption of Police Colonel Redrico A. Maranan;

WHEREAS, the Sangguniang Panlalawigan would like to be informed of the new plans and programs to be spearheaded by the present administration under the leadership of Police Colonel Redrico A. Maranan;

WHEREAS, it is the desire of the Sangguniang Panlalawigan to be updated of the steps and actions to be undertaken by the Philippine National Police to solve criminalities and lawlessness in the Province especially if it is presumed that Manaoag, Pangasinan may be considered as one of the vulnerable targets by a terror group;

WHEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


