#### **PROVINCIAL RESOLUTION NO. 447-2019**

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES FOR THE INSTALLATION OF A SECOND OFFSITE AUTOMATED TELLER MACHINE (ATM) TO BE LOCATED AT THE PROVINCIAL CAPITOL COMPOUND PARTICULARLY AT THE MALONG BUILDING

**WHEREAS**, the Land Bank of the Philippines, the primary depository bank of the Province of Pangasinan, is a partner of the provincial government in promoting countryside development;

WHEREAS, there exists an LBP offsite Automated Teller Machine (ATM) at the premises of the Finance Building which is not enough to service the officials and employees of the provincial government considering that it is now adopting the ATM Payroll System;

**WHEREAS**, an additional ATM unit of the Land Bank of the Philippines is therefore needed to service the Provincial Government and its nearby clientele;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Honorable Governor Amado I. Espino III, and the Land Bank of the Philippines, represented by Assistant Vice President Kathleen D. Fernandez, Branch Head, Lingayen Branch;
