PROVINCIAL RESOLUTION NO. 448-2019

AUTHORIZING SPECIAL TASK FORCE MEMBERS, ENGR. ALVIN BIGAY, ATTY. GERONIMO ABAD AND ENGR. EDGARDO D. ANCHETA, TO FACILITATE THE REQUIREMENTS FOR RECLASSIFICATION AND/OR CONVERSION OF THE PARCEL OF LAND OWNED BY THE PROVINCE OF PANGASINAN WITH AN AREA OF FIFTEEN (15) HECTARES, MORE OR LESS, LOCATED IN BARANGAY POBLACION, BUGALLON, PANGASINAN

WHEREAS, the Province of Pangasinan purchased an unirrigated agricultural land located in Barangay Poblacion, Bugallon, Pangasinan with an area of fifteen (15) hectares, more or less, intended for the construction of multi-purpose convention center;

WHEREAS, there is a need to reclassify and/or convert the abovementioned parcel of land from agricultural purpose to institutional and commercial purposes;

WHEREAS, one of the requirements for the reclassification of the said parcel of land is a Certification from the Department of Agriculture (DA) determining that the land ceases to be economically feasible and sound for agricultural purposes pursuant to Section 1, paragraph (b) of Memorandum Circular No. 54;

WHEREAS, under Section 65 of Republic Act No. 6657 as amended, Executive Order No. 129-A and paragraph 13, Section 3, Title XI of the Revised Administrative Code of 1987, likewise, requires a Certification from the Department of Agrarian Reform (DAR) approving applications for land use conversion of agricultural lands to non-agricultural uses;

WHEREAS, since the said parcel of land is owned by the Province of Pangasinan, a local government unit and in anticipation that these national government agencies and such other instrumentalities concerned may require the submission of Sangguniang Panlalawigan resolution authorizing the documentary processing of the parcel of land for reclassification and/or conversion, there is a need to authorize the aforementioned task force to facilitate the same;
