**APPROVING RESOLUTION NO. 122, S-2021 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 1 WITH THE CY 2021 SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 00 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 122, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of Republic Act No. 7160;

**WHEREAS**, the Local Development Council of Asingan, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2021 which was endorsed to the Sangguniang Bayan for approval on February 5, 2021 by the Municipal Development Council through MDC Resolution No. 1, Series of 2021;

**WHEREAS**, Supplemental Investment Plan of the municipality covers the reprogramming/realigning of some programs of present and previous years to augment funding for COVID-19 programs/projects/activities;

**WHEREAS**, the new 19 programs/projects/activities to be funded by the 20% development plan conform to Section 2.1 of the DILG & DBM Joint Memorandum Circular No. 01 dated March 27, 2020 (*Additional Guidelines on the Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects in view of the Corona Virus Disease 2019 Situation*);

**WHEREAS**, the realignment/reprogramming of the identified programs/projects/activities to be funded by the 5% Local Disaster Risk Reduction and Management Fund/30% Quick Release Fund of the municipality amounting to Php3,611,680.00 conforms with Section 21 of RA No. 10121 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (*Allocation and Utilization of Local Disaster Risk Reduction Management Fund*);

**WHEREAS**, funding support for the proposed Supplemental Investment Plan which has a total investment requirement of Php5,161,680 is embodied in the municipality's Supplemental Budget No. 2, for CY 2021, which was enacted by the Sangguniang Bayan on March 25, 2021 through Appropriation Ordinance No. 2, Series of 2021;




