DECLARING ORDINANCE NO. 2018-15 OF THE SANGGUNIANG PANLUNGSOD OF **ALAMINOS.** "AN PANGASINAN, ENTITLED **ORDINANCE TRANSFERRING FOUR (4) PLANTILLA POSITIONS** UNDER THE EXECUTIVE DEPARTMENT, TO WIT: **ADMINISTRATIVE AIDE II (MESSENGER) FROM THE OFFICE OF THE CITY MAYOR TO THE OFFICE OF THE CITY TREASURER; ECONOMIST I FROM THE OFFICE OF THE CITY COOPERATIVE OFFICER TO THE OFFICE** PLANNING AND DEVELOPMENT OF THE CITY **COORDINATOR; ADMINISTRATIVE AIDE VI (CLERK III)** FROM THE OFFICE OF THE CITY ENGINEER TO THE OFFICE OF THE CITY ASSESSOR AND ENVIRONMENTAL MANAGEMENT **SPECIALIST** Π FROM THE OFFICE OF THE CITY TOURISM OFFICER TO THE OFFICE OF THE CITY GENERAL SERVICES **OFFICER" AS WITHIN THE CONFERRED POWERS OF** THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and cosponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2018-15 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled "An Ordinance transferring four (4) plantilla positions under the Executive Department, to wit: Administrative Aide II (Messenger) from the Office of the City Mayor to the Office of the City Treasurer; Economist I from the Office of the City Cooperative Officer to the Office of the City Planning and Development Coordinator; Administrative Aide VI (Clerk III) from the Office of the City Engineer to the Office of the City Assessor and Environmental Management Specialist II from the Office of the City Tourism Officer to the Office of the City General Services Officer" as within the conferred powers of the Sangguniang Panlungsod to enact;
