## **RESOLUTION NO. 454-2022**

DECLARING MUNICIPAL ORDINANCE NO. 2022-01 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (MDRRMO) AND PROVIDING BUDGETARY REQUIREMENTS THEREOF AND ADOPTING POLICIES TO GOVERN ITS ORGANIZATIONAL STRUCTURE AND STAFFING PATTERNS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Agno, Pangasinan submitted its Ordinance No. 2022-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province, Provincial Legal Officer and the Human Resource Management and Development Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii), 325 (a), 317 (b-2) of R.A. No. 7160 and Joint Memorandum Circular No. 2014-1 dated April 4, 2014 of the NDRRMC-DILG-DBM-CSC, Section 12 of R.A 10121(Philippine Disaster Risk Reduction and Management Act of 2010, and Section 83 of R.A 10352 (General Appropriations Act F.Y 2013);
