DECLARING MUNICIPAL ORDINANCE NO. 2022-02 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE PLANTILLA POSITION OF MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (MDRRMO), SG-24 AT THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE OF THE MUNICIPAL GOVERNMENT OF AGNO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
