#### **RESOLUTION NO. 456-2019**

APPROVING RESOLUTION NO. 05-2019 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM FOR CY 2019 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Resolution No. 05-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Municipal Development Council of San Jacinto, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2018. This was endorsed by the Council to the Sangguniang Bayan thru MDC Resolution No. 2018-2 dated October 29, 2018 and was favorably acted upon by the Sangguniang Bayan on July 5, 2019 thru SB Resolution No. 05-2019;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of

> San Jacinto, Pangasinan was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund. c) Disaster Reduction Risk Programs/Projects/Activities, and d) Activities in pursuance of the objectives of GAD of the LGU. Also attached to the AIP, among others, are the following: a) DILG-endorsed Gender and Development Plan and Budget, b) Municipal Disaster Risk Reduction and Management Investment Plan, c) Local Climate Change Action Plan, d) Peace and Order Plan, e) List of Programs/Projects/Activities (PPAs) for the Local Council for the Protection of Children, f) List of PPAs for Senior Citizens and Persons with Disability, and g) List of PPAs to combat Acquired Immune Deficiency Syndrome (AIDS);

> WHEREAS, the AIP of San Jacinto for CY 2019 has a total investment requirement of P681,728,820.38. Of this, the sum of P131,714,612.17 will be financed by the LGU from the General Fund as embodied in their 2018 Annual Budget passed and approved by the Sangguniang Bayan through Appropriation Ordinance No. 01, S-2019 dated July 5, 2019. The remaining amount will be sourced from the LGU's Trust Fund for Unexpended LDRRMF, DILG's Assistance to Municipalities Program and from various national government agencies;

**WHEREAS,** said AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P107,543,603.00), amounting to P21,508,720.60 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs and projects included in the 5% Local Disaster Risk Reduction and Management Fund amounting to P6,445,930.15 are in accordance to Section 21 of RA 10121 and Memorandum Circular No. 2013-1 of the NDRMMC, DBM & DILG dated March 25, 2013 (Joint Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Apart from the 5% LDRRM Fund, the LGU's Trust Fund for the Unexpended LDRRMF in the amount of P5,062,208.21 is also included in the LDRRM Plan and AIP of the LGU. Compliance to Section 21 of RA No. 10121 (Philippine Disaster Risk Reduction and Management Act of 2010) which provides that the unexpended

LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the LDRRMC within the next five (5) years is recommended. The LDRRM Plan was reviewed by the Office of the Civil Defense-Regional Office 1 using the Provincial Review Tool and Checklist for the conduct of review and local DRRM Plans. It is therefore recommended that the LGU should comply with the recommendation of the OCD-RO1 as per their review of their LDRRMP;

WHEREAS, the Gender and Development Plan and Budget for CY 2019 of the LGU has been reviewed and approved by the Department of Interior and Local Government (DILG) Provincial Office, and found to be compliant in form and content with the provisions of the Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";

WHEREAS, the LGU had also identified programs, projects and activities which are responsive to Climate Change and tagged its corresponding expenditures in its AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 05-2019 of the Sangguniang Bayan of **San Jacinto**, Pangasinan, entitled "Approving the Annual Investment Program for CY 2019 of the Municipality of San Jacinto, Pangasinan";
