RESOLUTION NO. 457-2022

APPROVING RESOLUTION NO. 26-2022 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CALENDAR YEAR 2022 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its SB Resolution No. 26-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Urbiztondo, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on January 28, 2022 by the Municipal Development Council through Resolution No.01. S-2022;
2. The Supplemental Investment Program No. 1 of the municipality covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and implementation of various programs and projects of the municipality;

3. The proposed Supplemental Investment Program has an investment of P9,568,350.55. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 1, CY 2022, which was enacted by their Sangguniang Bayan on February 7, 2022 through Appropriation Ordinance No. 1-2022.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Urbiztondo, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—


