## **RESOLUTION NO. 461-2022**

APPROVING RESOLUTION NO. 75, S-2022 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, "APPROVING **ENTITLED** SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 1 CALENDAR YEAR 2022 OF THE MAPANDAN, **PROVINCE** MUNICIPALITY **OF** PANGASINAN. AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Mapandan, Pangasinan submitted its SB Resolution No. 75, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- The Municipal Development Council of Mapandan, Pangasinan prepared the municipality's Supplemental Annual Investment Plan No. 1 CY 2022. This was endorsed by the Council through MDC Resolution No. 01, S.2022 dated February 24, 2022 to the Sangguniang Bayan for approval;
- Said Supplemental Annual Investment Program, which has a total investment requirement of P22,032,033.51, covers the granting of salaries and other personnel benefits for the newly-created positions, and implementation of priority projects of the LGU;

3. Funding for the Supplemental AIP of the LGU is embodied in their Supplemental Budget No. 1, CY 2022, and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 1, Series of 2022 dated March 4, 2022.

**WHEREAS,** the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mapandan, Pangasinan;
