23, S-2020 APPROVING RESOLUTION PANGASINAN, **OF** CALASIAO, SANGGUNIANG BAYAN ENTITLED "APPROVING RESOLUTION NO. 3, S-2020 OF THE COUNCIL MUNICIPAL **DEVELOPMENT ENTITLED** "RESOLUTION ENDORSING REVISED ANNUAL INVESTMENT PROGRAM 2020 OF CALASIAO, PANGASINAN FOR CALENDAR **YEAR 2020"** 

**WHEREAS**, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 23, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Calasiao, Pangasinan proposed for the revision of the municipality's Annual Investment Program (AIP) fort CY 2020. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 03, Series of 2020 dated February 24, 2020 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 23, S-2020 dated March 2, 2020;

WHEREAS, the AIP was revised to include new/additional projects and activities amounting to P5,319,184.22 from the Unexpended MDRRM Fund (CYs 2018 and 2019)/Trust Fund of the municipality. The new/additional projects and activities are covered in the Revised Local Disaster Risk Reduction and Management Fund Improvement Plan (LDRRMFIP). The LDRRMFIP was prepared and endorsed by the Municipal Disaster Risk Reduction Management Council through MDRRMC Resolution No. 01-2020 dated February 25, 2020 to the Sangguniang Bayan and was favorably acted upon through SB Resolution No. 23, S-2020 dated March 2, 2020;
