**DECLARING MUNICIPAL ORDINANCE NO. 2021-02 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED “AN ORDINANCE DESIGNATING THE PARKING TERMINALS AND STAGING POINTS FOR TRICYCLES IN THE MUNICIPALITY OF BINALONAN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**
