DECLARING RESOLUTION NO. 69-2019 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE COMPREHENSIVE LAND USE PLAN (CLUP) FOR CALENDAR YEAR 2017-2026 OF THE MUNICIPALITY OF ROSALES, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Resolution No. 69-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, and Provincial Land Use Committee, have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Section 447 (a) (2) (vii) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Comprehensive Land Use Plan (CLUP) of Rosales, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to the guidelines of Memorandum Circular No. 2000-130 of the Department of the Interior and Local Government as embodied in Section 2 (b) of Executive Order No. 72, S-1993;
