DECLARING ORDINANCE NO. 02, S-2022 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "AN ORDINANCE ABOLISHING THE VACANT POSITIONS OF LOCAL LEGISLATIVE STAFF ASSISTANT I (LLSA-I) AND LOCAL LEGISLATIVE STAFF EMPLOYEE II (LLSE-II) UNDER THE OFFICE OF THE MUNICIPAL VICE MAYOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
