DECLARING CITY ORDINANCE NO. 2021-06 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING THE SISTERHOOD AND TWINNING COMMITTEE, PROVIDING GUIDELINES FOR SISTER-CITY/ TOWN TWINNING PARTNERSHIPS FOR THE CITY OF ALAMINOS, PANGASINAN AND OTHER LOCAL GOVERNMENT UNITS, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES" AS AWITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its City Ordinance No. 2021-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 33 of the Implementing Rules and Regulation of RA 7160 and DILG Memorandum Circular No. 2012-23 dated February 6, 2012;

WHEREAS, subject ordinance shall take effect after the requirement of posting pursuant to Section 59 of RA 7160 is complied with;
