## **RESOLUTION NO. 471-2022**

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2022 OF AGUILAR, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P1,941,828.80, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2022 involving total appropriations of P1, 941,828.80, which was enacted on March 14, 2022 through Appropriation Ordinance No. 02, series of 2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

- That the appropriations for the implementation of the Third Tranche compensation adjustments shall be subject to the provisions of Local Budget Circular (LBC) No. 143 dated January 3, 2022 re Implementation of the Third Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Republic Act (RA) No. 11466;
- 3. That the creation of positions shall be in accordance with the provisions of Civil Service Commission Memorandum Circular No. 19, s. 1992 dated May 07, 1992 re Guidelines and Standards in the Establishment of Organizational Structures and Staffing Patterns in Local Government Units, and that priority shall be given to the creation of mandatory positions; and
- 4. That the Productivity Enhancement Incentive (PEI) in the amount of P5,000.00 each may be granted to qualified personnel not earlier than December 15 of every year, subject to the rules and regulations provided under BC No. 2017-4 dated December 04, 2017.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 01 for Calendar Year 2022 of Aguilar, Pangasinan;

**RESOLVED FURTHER**, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Aguilar, Pangasinan, for its information and guidance.
