DECLARING ORDINANCE NO. 160, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE GRANTING OF MONTHLY CASH INCENTIVES TO BARANGAY PRESIDENTS OF THE PERSONS WITH DISABILITIES (PWDs) OF THE MUNICIPALITY OF BASISTA, PANGASINAN TO BE SOURCED FROM THE PWD'S FUND OF THE LOCAL GOVERNMENT OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 160, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (b) (2) (iv) and 447 (a) (5) (xiv) of R. A. No. 7160, Republic Act No. 7277, otherwise known as the "Magna Carta for Disabled Persons", Section 4 of the Implementing Rules and Regulations of R. A. No. 10754 (An Act Expanding the Benefits and Privileges of Persons with Disability (PWD), R. A. No. 10070-(Establishing Institutional Mechanism to Ensure the Implementation of Programs and Services for Persons with Disabilities in Every Province, City and Municipality, Amending Republic Act No. 7277, otherwise known as the Magna Carta for Disabled Persons, As Amended and for Other Purposes), and Convention on the Rights of Persons with Disabilities;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 160, S-2021 of the Sangguniang Bayan of Basista, Pangasinan, entitled "An Ordinance Institutionalizing the Granting of Monthly Cash Incentives to Barangay Presidents of the Persons with Disabilities (PWDs) of the Municipality of Basista, Pangasinan to be sourced from the PWD's fund of the Local Government of Basista, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
