DECLARING MUNICIPAL ORDINANCE NO. 126, S-2022 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING SECTION 4, QUALIFICATION STANDARDS FOR THE POSITION OF NURSE II AS STATED IN MUNICIPAL ORDINANCE NO. 121, SERIES OF 2021” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT


