RESOLUTION NO. 478-2022

DECLARING MUNICIPAL ORDINANCE NO. 20-2021 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE 18,780 SQ. M. LOT OWNED BY RAMON B. LEONOR, JR., FROM AGRICULTURAL INTO COMMERCIAL LOT PURPOSES LOCATED AT BARANGAY CABANBANAN, MANAOAG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Ordinance No. 20-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Provincial Planning and Development Coordinator, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the Municipality of Manaoag has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 1996-2005, however said CLUP and Zoning Ordinance, should be updated;

WHEREAS, Clearance for Reclassification (Certifications) from the Department of Agriculture and Department of Agrarian Reform must be secured and submitted to the Sangguniang Panlalawigan before the subject ordinance will be implemented;




