DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2020 OF ANDA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P11,460,061.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2020 involving total appropriations of **P11,460,061.00** which was approved on April 22, 2020 and was approved by the Municipal Mayor on April 30, 2020 through Appropriation Ordinance No. 01, S-2020;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the finding that the appropriation and utilization of the Bayanihan Grant to Cities and Municipalities shall be in accordance with the Local Budget Circular No. 125 dated April 7, 2020;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the finding shall be complied with by the municipality and shall notify the offices concerned of the actions taken thereon;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
