## RESOLUTION NO. 479-2022

DECLARING MUNICIPAL ORDINANCE NO. 2022-02 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING THE RECLASSIFICATION OF LAND SITUATED AT BARANGAY GUILIG, MUNICIPALITY OF MANGALDAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Ordinance No. 2022-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Provincial Planning and Development Coordinator, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160;

**WHEREAS,** the Municipality of Mangaldan has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2016-2026 wherein said parcel of land is classified as agricultural under the agricultural zone;

WHEREAS, Clearance for Reclassification (Certifications) from the Department of Agriculture and Department of Agrarian Reform must be secured and submitted to the Sangguniang Panlalawigan before the subject ordinance will be implemented;
