#### APPROVING MUNICIPAL RESOLUTION NO. 78-2020 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 01, S-2020 OF THE MUNICIPALITY OF ANDA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Resolution No. 78-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Anda, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on March 18, 2020 by the Municipal Development Council through MDC Resolution No. 01, S-2020 and was favorably acted upon by the Sangguniang Bayan dated March 20, 2020 through SB Resolution No. 78-2020;

**WHEREAS**, the Supplemental Investment Program No. 1 of the municipality with an estimated investment requirement of P15,767,067.62 covers the programs/projects/activities to address the crisis brought about by the COVID-19 pandemic to be funded from the Quick Response Fund 2020 (P2,115,000.00) balances of 70% LDRRMF 2020 (P4,179,565.00) and from the unexpended LDRRMF (2015, 2016, 2017, 2018 and 2019) (P9,472,506.62). This is in accordance with Section 2.5.5 of Local Budget Circular No. 124 dated March 26, 2020;
