RESOLUTION NO. 481-2020

APPROVING MUNICIPAL RESOLUTION NO. 82-2020 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 03, S-2020 OF THE MUNICIPALITY OF ANDA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Resolution No. 82-2020, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Anda, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on May 5, 2020 by the Municipal Development Council thru MDC Resolution No. 03, S-2020 and was favorably acted upon by the Sangguniang Bayan on May 6, 2020 thru SB Resolution No. 82, S-2020;

WHEREAS, the Supplemental Investment Program No. 3 of the municipality covers the projects to address the outbreak of African Swine Fever (ASF) based on the declaration of State of Calamity of the entire Municipality of Anda by the Sangguniang Bayan on April 27, 2020. These projects are proposed to be funded from the realigned portion of Quick Response Fund initially intended for COVID-19 general operations. This was endorsed by the LDRRMC thru MDRRMC Resolution No. 04, Series of 2020, dated April 30, 2020;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


